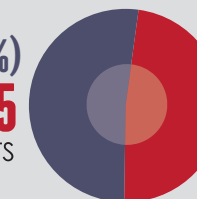
FUNDING

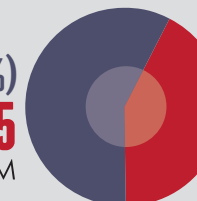
